



CSQ Higher Qualifications Program

As a recipient of Construction Skills Queensland's (CSQ) funding, TAFE Queensland are proud to support their ongoing financial and professional contribution to the Queensland building and construction industry.

The CSQ Higher Qualifications program helps existing and unemployed workers in the building and construction industry to gain new skills and knowledge to further their career. Certificate IV level vocational training qualifications are available under this program.

How does it work?

CSQ funding is paid directly to TAFE Queensland. Where CSQ funding doesn't cover the full cost of your fees you will be required to contribute towards the remaining course fees.

Participants are only eligible to study **a maximum of one CSQ funded Higher Qualification** between **19 August 2024 and 28 February 2026**. No more than 50% of the qualification can be obtained through Recognition of Prior Learning (RPL) or credit transfer.

To take advantage of this funding, **enrol by 31 July 2025 and ensure you complete one unit of competency to continue your studies past this date with funding.** Complete your qualification by 28 February 2026.

*Funded courses are only available at select locations.

Eligibility.

To be eligible for funding, participants must be eligible workers (including relevant clerical, administration and professional staff) or unemployed eligible workers (i.e. unemployed for less than 6 months) in the civil construction or building and construction industries in Queensland and are one of the following:

- An Australian or New Zealand citizen
- A permanent resident of Australia
- A visa holder with the right to work in Australia and who has been working in the Queensland Building and Construction Industry for 6 months or more (excluding international student visa holders)

Eligible workers must be employed in Queensland. Additional eligibility requirements may apply.
